MOORAGE CONTRACT, TERMS AND CONDITIONS -2010

THE FOLLOWING SECTIONS CONTAIN IMPORTANT INFORMATION THAT MAY AFFECT YOUR LEGAL RIGHTS. YOU MUST READ THE FOLLOWING MATERIAL BEFORE SIGNING THIS CONTRACT.

This contract between the Vessel owner "OWNER" and the City of Seward "CITY", governs the Owner's use of reserved moorage space in the Seward Municipal Small Boat Harbor ("Harbor")...

Owner's Responsibilities: Owner agrees that, if City assigns Owner the use of reserved moorage space, and Owner or Owner's agent or employee fails to comply with the terms of this agreement, the City Code, or the Harbor Tariff...

Payment of Fees: Owner agrees to pay moorage charges, tariffs and fees for any service that Owner or Owner's agent or employee orders or that is necessary in an emergency to protect any facility within the Harbor...

Rental Agreement Only: Owner agrees and understands that this agreement is a moorage space rental agreement only and that by accepting this contract and assigning to Owner the use of reserved moorage space...

Limitation of Liability: City shall not be liable for any loss or damage hereunder from any cause whatsoever, except and to the extent SOLELY caused by the City's own negligence or intentional misconduct.

Owner's Obligation to Defend, Hold Harmless, and Indemnify: Owner hereby releases and agrees to defend, hold harmless, and indemnify the City and its officers, employees, and agents from and against any and all losses, claims, demands, actions, damages, liabilities, or expenses of every kind...

Insurance: Owner agrees to provide liability insurance covering the Vessel and owners employees, invitees, guests, and agrees to provide the City proof of such insurance. The coverage afforded may be determined by the owner in conjunction with the insurer...
